That is why we are launching the national chapter of the Council of Europe campaign "Journalists matter" for the safety of journalists in Ukraine





#### What are we going to do?

- Gather all stakeholders of the process (journalists, NGOs, human rights activists, government representatives) in one place
- Facilitate the work of the newly created Coordination Committee under the Ministry of Culture and Information Policy of Ukraine for the implementation of the Council of Europe campaign "Journalists Matter"



- Conduct an assessment of issues and challenges regarding journalists' safety in Ukraine, which should include aspects such as physical security, economic security, mental health protection, and combating sexism, gender-based violence, violence related to the professional activities of female journalists
- Approve the Action Plan by the Coordination Committee
- Share the best Ukrainian practices in protecting journalists and other media actors

#### The Coordination Committee included representatives of:

- The Ministry of Culture and Information Policy of Ukraine
- The National Council of Television and Radio Broadcasting of Ukraine
- The State Committee for Television and Radio Broadcasting of Ukraine
- The Prosecutor General's Office of Ukraine
- The Ministry of Foreign Affairs of Ukraine
- The Ministry of Internal Affairs of Ukraine
- Representatives of other central and local executive authorities
- The National Union of Journalists of Ukraine
- The Commission on Journalistic Ethics
- Independent media experts, specialists, and consultants (with their consent may be involved in the Committee's work)



#### The main tasks of the Coordination Committee include:

- Assessing existing challenges and needs (considering the internal environment in which journalists and other media actors operate).
- Providing recommendations for implementing the Council of Europe's campaign on the safety of journalists 'Journalists Matter' in Ukraine at the national level, starting with assessing needs and identifying useful measures that can be implemented within the campaign.
- Summarising practices, providing recommendations and proposals for creating favorable conditions for professional activities of journalists and other media actors in Ukraine.
- Discuss incidents of war crimes against journalists and media, underlining the imperative for protection of free speech and international support.
- Identifying ways, mechanisms, and methods of addressing problematic issues related to journalists' safety, conducting their professional activities during the legal regime of martial law.
- Addressing other issues related to protecting freedom of expression in Ukraine.

The Coordination Committee will approve the Action Plan, which can be amended as needed




## The Council of Europe Platform for the Protection of Journalism and Safety of Journalists

#### We intend to:


- systematically review all alerts on Ukrainian page at Coordination Committee meetings;
